## Not everyone has belief in spiritualism

An OBSERVER article headlined, "Strange 'happening': Activity spurs probe at museum" on April 24 certainly captured the attention of many believers, skeptics and critics of so-called "paranormal activity." The article was well written and will, no doubt, greatly contribute to marketing the Darwin R. Barker Museum in a compelling new way.

Chautauqua County is, after all, the home of the center for the religion of Spiritualism at Lily Dale that attracts an estimated 22,000 visitors per year.

From Wikipedia, we read: "Spiritualism is a new religious movement based on the belief that the spirits of the dead exist and have the ability and the necessary means to communicate with the living. The afterlife, or the "spirit world," is seen by spiritualists, not as a static place, but as one in which spirits continue to evolve. These two beliefs—that contact with spirits is possible, and that spirits are more advanced than humans — lead spiritualists to a third belief: that spirits are capable of providing useful knowledge about moral and ethical issues, as well as about the nature of God. Some spiritualists will speak of a concept which they refer to as 'spirit guides' — specific spirits, often contacted, who are relied upon for spiritual guidance."

As an Orthodox Christian, I am most emphatically not a Spiritualist.

#### Library and Museum closing policy

The library and museum will close in emergency situations when the health or safety of staff and patrons may be at risk, or for any reason as may be deemed necessary. Examples of situations that would warrant emergency closings include inclement weather or serious problems with building maintenance such as, but not limited to, a lack of heat or a gas leak.

The decision to close will be made by the executive director in cooperation with the board president and curator.

In some circumstances, such as, but not limited to, a pandemic or damage to the building, the library and museum may close to the public, but certain staff may be asked to report for duty to allow for curbside pick-up and/or other tasks. They may also be asked to work remotely if circumstances require.

The executive director will notify staff and local news outlets, and will put notices on social media and the library and museum's websites regarding the closing that morning, before the library and museum would have opened.

The library and museum will follow the Fredonia schools in deciding whether to close for inclement weather.

#### Darwin R. Barker Art Display Policy Agreement

- 1. The Artist hereby assumes all risks and hazards incidental to any participation in the display of their artwork at the Barker Library.
- 2. Artwork exhibited must be appropriate for viewing by all ages of the general public. Artwork that is of an overtly sexual, racist, violent, libelous, slanderous, demoralizing, or discriminatory nature is strictly prohibited. The determination will be made at the discretion of the library director.
- 3. The Artist warrants and represents that they are the sole legal owner of all right, title and interest in all Artwork and has the full right and authority to enter this Agreement and grant the rights granted in this Agreement. The Artist understands that, by displaying their work in public, it is impossible for the Library to prevent it from being photographed.
- 4. The Artist is responsible for the delivery, pack, transport, return and hanging of the submitted artwork at their own risk and expense.
- 5. Display space is provided free of charge and is for the purpose of display only. The Artist is allowed to display a monetary value for the artwork and post their personal contact information near the artwork. Any sales the artist makes are a private transaction between the artist and the buyer. The library will not facilitate any transactions, will not handle any cash, and is not a party to any sales made by the artist.
- 6. The Artist understands that the artwork is submitted to the Barker Library and exhibited at the Artist's own risk and that neither the Barker Library nor any of its officers, agents, and employees shall be responsible for theft, vandalism, fire, or any other damages or losses to the artwork. The Artist understands and agrees that the Barker Library makes no representations or warranties regarding the level of security in the Library or premises. The Artists understands and agrees that Barker Library and its officers, agents, and employees will not be responsible for reimbursement or replacement of lost, stolen, or damaged items and that the Barker Library does not insure items such as the submitted artwork. The Artist understands and agrees that

the Barker Library encourages the owner of the artwork or the owner's agent to obtain an insurance policy for the artwork or to obtain a rider on any existing policy for the duration of the exhibit.

7. Artist shall indemnify, save and hold harmless the Barker Library, its officers, directors, employees, volunteers and agents and the participating artist from any and all claims, demands, causes of action and judgments, losses, costs and expenses, including but not limited to reasonable attorney's fees, arising due to the negligence of Artist, their employees, agents or other personnel hereunder, including but not limited to any representation, warranty, term and/or condition of this Agreement.

#### Curator's Report

#### **Exhibits**

- LaBella Associates conducted ceiling cuts and preliminary inspection from the structural engineer suggests a loading capacity of 125 lbs/sq ft in Room 201, the second floor storage area. Samples of the wood girders and joists have been sent to a Syracuse University lab for analysis, and further information is expected in a forthcoming structural report.
- Plexiglass guards have been installed around the ceiling cuts to enable visitors to view the 1821 construction materials indefinitely. Plexi frames are removable.
- Photography exhibit, Fredonia in Focus, will open on Saturday, May, 21.
- Manly gallery has been patched and painted by volunteers.
- NCCF grant received for the December exhibit, Mark Twain in Fredonia, in the amount of \$2,250.
- Next steps: finalizing the artifact list for Mark Twain exhibits in preparation for the conservator's visit planned for November.
- Proposal for collaborative exhibition with the Dunkirk Historical Museum has been brought before the DHM's board of trustees. Content will focus on the growth of the fossil fuel and railroad industries which connects the two municipalities. Schedule TBD.
